

## GRAND LODGE OF WESTERN AUSTRALIAN FREEMASONS (INC) THE FREMANTLE LODGE NO. 2 WAC (late 1033EC)

The Lodge was consecrated on the 1 June 1865 and gave its allegiance to the WAC on 27 February 1900. On the 8 June 1993 Applecross Lodge No. 175 WAC amalgamated with the Fremantle Lodge No. 2 WAC to become the Applecross-Fremantle Lodge NO. 2 WAC. It is still active at the year 2000.
