

GRAND LODGE OF WESTERN AUSTRALIAN FREEMASONS (INC) LODGE FRIENDSHIP NO. 17 WAC (late 2618 EC)

The Lodge was consecrated on the 27 February 1900 under the English Constitution and was a founding member lodge of the Grand Lodge of WA Freemasons and was allocated No.17 WAC. Friendship Lodge amalgamated with Lodge Helena Vale No. 253 WAC under the title of Lodge Helena Vale with Friendship No. 17 on 9 June 1999.
