LODGE OF UNITY NO. 11 WAC (FORMERLY NO. 2452 E.C.)**

The Lodge was consecrated on the 5 September 1892 under the English Constitution at the Masonic Hall, Howick Street (now Hay Street), Perth. The Lodge was a founding member Lodge of the Grand Lodge of WA Freemasons and was allocated No. 11 WAC. The Lodge is still active at this time (2005).
