(formerly Scottish Constitution unnumbered), Temple Street, Victoria Park

The Lodge had its first meeting, under the Scottish Constitution, for the installations of the Right Worshipful Master and the investiture of Officers, on 4 January 1901, at the Town Hall, Victoria Park. The Lodge subsequently gave its allegiance to the newly formed Western Australian Constitution, and was consecrated and given the number 48 on the 22 February 1901 by the Most Worshipful Pro Grand Master Bro. Sir Winthrop Hackett, MLC.
