The Perth Chamber of Commerce was established in July 1890. From its first years the Perth Chamber of Commerce was concerned with protection of mercantile interests in the colony. Today the Perth Chamber of Commerce aims to promote commerce, encourage trade, monitor government policy, arbitrate in times of dispute, establish and maintain a code of practice and provide information for business when it is required.
