

RIVER DISTRICTS ASSOCIATION

The River Districts Association began as the North West Ward Ratepayers' Association in 1945. In 1987, due to a new Ward boundary being drawn between North and South Yunderup, they disbanded the North West Ward Ratepayers' Association and reformed as the River Districts Association. The organisation was dissolved in January 2002, when Doreen Trainor was Secretary. One of its main objectives was to support all legitimate moves and acts for the preservation of the environmental character of the riparian systems of the Shire of Murray in regard to flora, fauna and water quality. In 1982, they found amongst their papers the Minute Book of the Yunderup Progress Association which had flourished in Yunderup during the 1940s and early 1950s.
