

## **BURT, SEPTIMUS. (1847-1919)**

Son of Sir Archibald Paull Burt, Western Australia's first Chief Justice. Lawyer, politician and grazier. Legislative Councillor 1874-1886 and 1888-1890. Attorney General 1886. Appointed Q.C. 1887. Perth City Councillor 1881-1889. In the election that followed the introduction of Responsible Government in 1890, Burt was elected as member of the Legislative Assembly for Ashburton. He served as Attorney General under John Forrest between. 1891 - 1897 and retired from the Assembly and political life in April 1900.
