The Goldfields of Coolgardie, East Coolgardie, North Coolgardie, and Yilgarn, are connected with the port of Fremantle, from which a railway extends as far as Kalgoorlie. The distance from Fremantle to Southern Cross is 248 miles; from Southern Cross to Coolgardie 180 miles, and from thence 24 miles to Kalgoorlie. From these centres roads branch out to all the various mining centres of these fields.

The Goldfields of Murchison, East Murchison, and Yalgoo are connected with the port of Geraldton, from which a railway extends to Yalgoo, 130 miles, and is in construction from thence, via Mount Magnet, to Cue, a further distance of 120 miles. From Cue to Lawlers, in the East Murchison Goldfield, the distance by road is 180 miles.

The Ashburton Goldfield is connected with the port of Onslow, by road about 150 miles. The West Pilbarra and Pilbarra Goldfields are connected with the port of Cossack, 13 miles from Boobourne. The small port of Gordon is situated also about 80 miles north from Marble Port Hedland, westward from Gordon. There is also a road about 100 miles in length to the Kimberley Goldfield.

The Kimberley Goldfield is connected with the port of Wyndham, in the Cambridge Gulf, which is 200 miles north from Hall's Creek. The Dundas Goldfield is connected by road with the small port at Esperance Bay, distant about 150 miles south from Norseman Town.

Dandalup Goldfield is connected by rail with Fremantle, from which it is distant about 60 miles.

Telegraph Stations have been established at Hall's Creek, Marble Bar, Bamboo Creek, Boobourne, Cossack, Cue, Nannine, Yalgoo, Southern Cross, Coolgardie, Kanowna, Kurralpi, Broad Arrow, Bardoc, Menzies, Dundas, and at the ports of the colony previously mentioned.

Mail Steamers from Europe and the Eastern Colonies call weekly, both ways, at Albany and direct, and from Singapore, call frequently at Fremantle and the ports along the coast.

There is a line of railway from Albany connecting with the Fremantle-Coolgardie line at Northam, a distance of 247 miles, trains running daily, and also a line of railway from near Perth to Geraldton. Passenger fares on the Government Railways are 2d. per mile first-class and 14d. second-class.

Mining Laws.—Under the existing Acts for Goldfields and Mineral Lands, the following Fees are charged:—

Miner's Right	10s., in force for Twelve Months.
Mining License	10s., in force for Twelve Months.
Gold Mining Lease	£1 per acre per annum; maximum, 24 acres; Survey Fees added.
Mineral Lease	5s. per acre per annum; maximum, 160 acres; Survey Fees added.
Coal Mining Lease	6d. per acre per annum; maximum, 640 acres.

Claims and Protection Areas can be taken up free of rent by holders of Miners' Rights or Mining Licenses.

Plans of Mining Centres and of the Goldfields and country generally, as well as of all Townsites, and copies of the Acts referring to Gold and other Mining and Land Regulations can be obtained on application at the Government Offices, or at the Warden's or Magistrates' Offices, at the uniform price of 1s. per copy.
