

(plug & washer), draw knives, drill holders, reamers & tyre measurers; vices, watchmakers' & jewellers' tools, wrenches (including pipe wrenches), washers & rivets, wedges, patent, for droppers & standards; wire, n.e.i., wire netting, wire cloth, wire gauze; zinc, bar, scrap & sheet, & circles & ingots, bored or unbored, for cyanide gold process; zinc blocks for marine boilers; ships' fittings, viz.: propellers, blades & bosses, liners for cylinders, shafting, winches, windlasses, steering gear, feed-water heaters, feed pumps, evaporators & auxiliary condensers (provided such fittings form duplicate part of & are used in connection with the ship in or for which they were imported), steel & steel-rimmed wheels for coal or slate trucks & wagons.

DIVISION VIA.—METALS.

To come into force on dates to be fixed by Proclamation, & exempt from duty in the meantime. Proclamation to issue so soon as it is certified by the Minister that the manufacture to which the Proclamation refers has been sufficiently established in the Commonwealth, according to the provisions of any law relating to bonuses for the encouragement of the manufactures, under the direct control of the Commonwealth or State Governments, but no Proclamation to issue except in pursuance of a joint address passed on the motion of Ministers of both Houses of Parliament, stating that such manufacture is sufficiently established.

Iron & steel:

DIVISION VII.—OILS, PAINTS & VARNISHES.

Blacking, including dressings, soaps, oils, inks, pastes, polishes, stains & varnishes for leather; Berlin & Brunswick blacks, furniture oil paste & polish & bronzing & metal liquids & powders, ad val. 20%

Special exemptions:—Earthenware, viz.:
Spurs, stilts & thimbles—Firebricks for special use in reverberatory furnaces, crucibles, scorifiers' roasting dishes, mullers, assay furnaces & cupels. Glass, viz.: Lenses, n.e.i., locket, brooch & watch glasses; bottles, empty, of not more than five fluid drams capacity. Scientific instruments & apparatus, viz.: Instruments for measuring the density of liquids, including hydrometers, saccharometers, lactometers, salinometers & barometers. Scientific apparatus (glass), viz.: Beakers, flasks, test tubes, vacuum tubes, burettes, pipettes, weighing bottles & tubes, endimeters, nitrometers, radometers, fat extraction tubes, filter pumps, gas washing, reduction & absorption bulbs & tubes, test measures in centimetres & grains; also carbonic acid, sulphuretted hydrogen, decomposing water & bacteriological apparatus of glass—Screens—Process engravers, dry gums, shellac, dextrine, sandarach & mastic—Bath bricks; oil & whet stones; also lithographic & emery stones; pestles & mortars (agate); stone, viz.: sawn or in the rough, n.e.i.

DIVISION IX.—DRUGS & CHEMICALS.

Acetic acid, extract or essence of vinegar & vinegar: Containing not more than 6% of absolute acid, per gallon, 6d

(except metal), in parts or finished, including billiard & bagatelle tables & boards & accessories, photograph frames & stands for pictures, picture frames (on pictures or otherwise) & picture mouldings, cabinets, brackets, trays, verandah blinds, screens, hair curled, show figures for draping or other purposes, writing & stationery cases, writing desks, & mirrors framed or set, ad val. 20%

Wicker, bamboo, cane or wood—All articles, n.e.i., made of, whether partly or wholly finished, including bellows, casks, shooks, sashes & frames, timber bent, n.e.i., wood cut into shape and dressed or partly dressed for making boxes or doors, walking sticks & canes, ad val. 20%
Axle & other unattached tool handles, ad val. 15%
Special exemptions:—Billiard balls in the rough; furniture (minor articles for): bindings (except leather), buttons, awstors, ferrets, gimps, lace (float & orris), tufts & fringes; timber; elm hubs, with or without metal bands; engravers' boxwood; logs not sawn; New Zealand pine, undressed; shafts & poles, sawn or bent, but not dressed; spurs in the rough; hickory spokes, dressed (2 inches & under in diameter); rims, spokes & felloes of hickory in the rough, staves, undressed or roughly dressed, but not shaped, hickory, undressed; vencers, wicker, bamboo cane, or wood, viz.: buckets, wooden canes & rattans, unmanufactured; cane, compressed, in sheet & unshaped; last blocks, rough turned; lasts & trees, wooden, wooden type, wooden type cases, type cabinets & cases; bamboo, clouded

DIVISION XI.—JEWELLERY & FANCY GOODS.

Fancy goods (not being partly or wholly of gold or silver), including:
Curl cases, snuff & match boxes, purses, thimbles, servietto rings, button-hooks, shoehorn & lifts, glove stretchers, toys, ivory & other ornamental figures, ornamental confectionery, feather dusters, paper parasols, articles used for outdoor & indoor games, fishing appliances, pencil cases, pencils & penholders, n.e.i., articles manufactured from pulp, papier maché, or indurated fibre, ad val. 20%
Jewellery, viz.:

Chain, machine-made in the rough, gallerie, coronets, beads, catches & joints for pins, clasps, points & brooch pins, ad val. 15%
Jewellery & imitation jewellery, including ornamental hair, hat & other pins, buckles & clasps for adornment, smelling & pocket perfume bottles, chatelaines, jewel cases, bolt & split rings, swivels, ear wires, bars & stampings used in the manufacture of jewellery; medals & all articles, n.e.i., partly or wholly made up of gold or silver, including gold or silver wire, ad val. 25%
Watches, clocks & chronometers, n.e.i., & parts thereof, time registers & detectors, opera, field & marine glasses, pedometers, pocket counters, kinematographs, kineoscopes, phonographs, graphophones, gramophones, cameras & magic lanterns, including accessories, ad val. 20%
Special exemptions:—Pencils & penholders of wood & metal clamps (not being of gold or silver); school pen and pencil sets in boxes; ballpoint & coin; gold & silver, bar, ingot & sheet; jewellery, viz.: canoes & precious stones, unset; ships' compasses; surveyors' compasses; pocket compasses (except when mounted in gold or silver); ships' chronometers; patent logs & sounding machines; kinematograph films with pictures thereon; microscopes, telescopes, spectacles (except gold, silver, or gold or silver plated); barometers & thermometers (except advertising), & watch & clock springs

DIVISION XII.—LEATHER & RUBBER.

Boots & shoes, except partly or wholly of lasting or stuff, English sizes to be the standard, viz.:
Men's sizes above 3, 30% ad val
Youths' sizes above 1, 30% ad val
Boys' 7-1, 30% ad val
Women's sizes above 2, 30% ad val
Girls' sizes above 10, 30% ad val
Girls' 7-10, 30% ad val
Slippers, leather, 20% ad val
Boots & shoes, n.e.i. (including indiarubber), golothes, slippers, n.e.i., boot & shoe uppers & tops, clogs & patens, wading boots, slipper forms in the piece or otherwise, cork, leather, or other socks or soles, ad val. 25%
