**NOTE.**  
 Stillbirths.—Under "The Registration of Births, Deaths, & Marriages Amendment Act, 1907," stillbirths have to be registered both as births & deaths within 14 days, subject to the same penalties as apply to registration of ordinary births & deaths.  
 Applicants for searches or certificates should furnish, as far as possible, the following particulars:—  
 Births & Deaths.—Full name, date & place, full name of both parents & maiden name of mother.

**Marriages.**—Full name of each of the parties, date & place of marriage, maiden name of bride & the name of the officiating clergyman.  
**Searches & Certificates.**—No search under any circumstances can be made or certified copy be issued until all the necessary fees are duly paid.  
**Remittances.**—Applications made from within the Commonwealth must not be paid for by means of postage stamps, but by either post office order, Commonwealth postal notes, or by W. A. revenue stamps. From outside the Commonwealth by post office orders only.  
**Special Marriage Licenses.**—The issuer, or the registrar-general, may at his discretion remit the whole or any portion of the fee.  
**Remission of Fees.**—The registrar-general may, under certain limited conditions, remit the whole or any portion of any fees payable.
