

POSTAL, TELEGRAPH AND MONEY ORDERS.

Letters.

Within the Commonwealth (including Papua, Lord Howe Island & Norfolk Island), for every 1/2 oz. or fraction thereof, 1d. United Kingdom, Overseas Dominions, British Colonies & Protectorates (except New Hebrides), for every 1/2 oz. or fraction thereof, 1d. New Hebrides, Banks & Torres Islands, 1/2 oz. 2d. Other countries, 1/2 oz. 2d.

Post Cards.

Within the Commonwealth (including Papua, Lord Howe Island & Norfolk Island), New Zealand & Islands, Fiji, United Kingdom & all British Colonies & Protectorates & United States of America, 1d. Letter cards, single, 1d.; reply, 2d.

Commercial Papers (up to 5 lb.).

Within the Commonwealth & New Zealand & the Islands annexed thereto, & Fiji, 2 oz. or fraction thereof, 1d. In all other places, for any weight not exceeding 2 oz. 3d.; between 2 oz. & 4 oz. 3d.; between 4 oz. & 6 oz. 4d.; between 6 oz. & 8 oz. 4d.; between 8 oz. & 10 oz. 5d.; each additional 2 oz. or fraction thereof, 1d.

Printed Papers (up to 5 lb.).

Within the Commonwealth, 1/2d. per 2 oz. or part of 2 oz. All other places, 1d. per 2 oz. or part of 2 oz.

Merchandise.

Within the Commonwealth & New Zealand & the Islands annexed thereto & Fiji, every 2 oz. or fraction thereof (up to 1 lb.), 1d. All other places beyond the Commonwealth, parcels rates are payable.

Patterns & Samples.

Within the Commonwealth & New Zealand & the Islands, 2 oz. or fraction thereof (up to 1 lb.), 1d. United Kingdom, 2 oz. or fraction thereof (up to 5 lb.), 1d. All other places, 2 oz. or fraction thereof (up to 12 oz.), 1d.

Books.

Within the Commonwealth, books printed in Australia, 1/2d. per 8 oz. or part of 8 oz.; books printed outside Australia, 1/2d. per 4 oz. or part of 4 oz.; to New Zealand & the Islands annexed thereto, Fiji, New Hebrides, and the Solomon Islands (British Protectorate), 1d. All other places, 1d. per 2 oz. or part of 2 oz.

Parcel Post.

Inland, not exceeding 1 lb. 6d. & 1d. for every additional lb. up to 11 lb. (limit). Size limit, 3 ft. 6 in. in length, or 6 ft. in length and girth combined; limit of weight, 11 lb.

United Kingdom—All Sea Route: 1 lb. 1s.; every additional lb. 6d. Via Brindisi or Naples: 1 lb. 2s.; every additional lb. 6d.; Size limit, 3 ft. 6 in. in length, or 6 ft. in length and girth combined.

Australian States, New Zealand, Fiji, New Hebrides & British New Guinea, first 1 lb. 8d.; each additional lb. or fraction, not exceeding 11 lb. or 3 ft. 6 in. in length, or 6 ft. length and girth combined, 6d. Canada, India & Straits Settlements, not exceeding 11 lb. 1s.; each additional lb. or fraction, 1s. up to 11 lb.

France, via London—1 lb. 1s. 10d.; 2 lb. 2s. 2d.; 3 lb. 2s. 5d.; 4 lb. 3s. 1d.; 5 lb. 3s. 4d.; 6 lb. 3s. 7d.; 7 lb. 3s. 10d.; 8 lb. 4s. 0d.; 9 lb. 4s. 3d.; 10 lb. 4s. 6d.; 11 lb. 4s. 9d.; size limit, not to exceed 2 ft. in any direction.

Germany, via London—1 lb. 1s. 7d.; 2 lb. 1s. 10d.; 3 lb. 2s. 1d.; 4 lb. 2s. 4d.; 5 lb. 2s. 7d.; 6 lb. 2s. 10d.; 7 lb. 3s. 1d.; 8 lb. 3s. 4d.; 9 lb. 3s. 7d.; 10 lb. 3s. 10d.; 11 lb. 4s. 1d.; size limit, not to exceed 2 ft. in any direction.

Canada—1s. per lb.; size limit, same as United Kingdom.

Cape Colony, via London—1 lb. 1s.; then 1s. every extra lb.; size limit, same as United Kingdom.

Hongkong, not exceeding 1 lb. 10d.; each additional lb. up to 11 lb. 10d.

China, not exceeding 1 lb. 1s. 5d.; each additional lb. up to 11 lb. 16d.

Newspapers.

If printed within the Commonwealth, within the Commonwealth, Fiji, New Zealand & Islands & Papua, every 10 oz. or fraction thereof, 1/2d.

United Kingdom, not exceeding 8 oz. 1d.; exceeding 8 oz. but not exceeding 10 oz. 2d.; every additional 2 oz. 1/2d.

For transmission wholly by sea per P. & O. or Orient steamers, 16 oz. 1d.

Elsewhere beyond the Commonwealth, not exceeding 4 oz. 1d.; every additional 2 oz. 1/2d.

Newspapers printed outside the Commonwealth, but posted within the Commonwealth to Fiji, New Zealand & Islands, 4 oz. 1/2d.

Magazines.

Within the Commonwealth (if printed in Australia), 8 oz. 1/2d.; if printed outside Australia, 4 oz. 1/2d.; New Zealand & Islands, Fiji, New Hebrides or Solomon Islands (British Protectorate), 8 oz. 1d.; every additional 4 oz. 1/2d.; other places, 2 oz. 1d.

Registered Letters.

Registration fee, 3d. (in addition to the ordinary postage).

Money Orders.

Throughout the Commonwealth, not exceeding £5, 6d.; above £5, but not exceeding £10, 1s.; each succeeding £5 or portion thereof, 6d. New Zealand & Fiji, £2 & under, 6d.; above £2 & not exceeding £7, 1s. 6d.; above £7 & not exceeding £10, 2s.; above £10 & not exceeding £12, 2s. 6d.; above £12 & not exceeding £15, 3s.; above £15 & not exceeding £17, 3s. 6d.; above £17 & not exceeding £20, 4s.

Orders payable in the United Kingdom, Canada, Cape of Good Hope, Ceylon, Egypt, Japan, China, Fiji, Germany, Hawaii, Sandwich Islands, India (& its Agency at Achen), Orange River Colony, Straits Settlements, Mauritius, Transvaal, Natal, United States of America, Argentine, Austria, Chili, Gibraltar, Greece, Holland, Hungary, Iceland, Italy, Jamaica, New Guinea, Norway, Philippine Islands, Portugal, Russia, Australian Post Office in Turkey, Federated Malay States &c. for each £1 or fraction thereof up to £10, 6d.

Interstate Postal Notes for sums from 6d. up to 20s. at nominal fees

TELEGRAPHIC.

All telegraph offices are notified as such in the Towns portion of the Directory. Rates.—Central & suburban (15 mile radius), 16 words and under, 6d.; each additional word, 1d. Beyond the 15-mile radius, 16 words & under, 8d.; each additional word, 1d. Sundays, Christmas Day & Good Friday, & between 8 p.m. & 9 a.m., double rates. Press messages for publication, 25 words & under, 6d.; 26 to 50, 8d.; 51 to 100, 1s. 6d.; each additional 20, 6d.

Interstate, 16 words, 1s.; each additional word after 16 words, 1d.; Sundays, Christmas Day & Good Friday, 16 words, 2s.; each additional word 2d.

Urgent telegrams, double the above. To New Zealand, 1/2d. per word.

To London, 3s. per word (words containing more than 10 letters count two words).

To Europe, 3s.; Aden, 2s. 8d.; Hongkong, 2s. 6d.; India, 2s. 6d.; Japan, 4s. 2d.; Singapore, 2s. 6d.; Egypt, 3s. 8d. to 4s. 3d.; Capetown, 2s. 8d.; Ceylon, 2s. 6d.; Jamaica, 3s. 4d.; California, 2s. 4d.; New York, 2s. 8d. each word.

Telegraphic Money Orders made payable at any money order office which is also a telegraph office in Tasmania, New South Wales, Queensland, South Australia, Victoria, Western Australia & New Zealand, on payment of a message of 10 words, in addition to the money order commission.
