NOTARIES.

Every person applying to be appointed a Public Notary must, after obtaining a certificate from the Chief Justice as to fitness and the necessity of such appointment, advertise his intention to apply to the Full Court on a day not earlier than four weeks from the first advertisement to be so appointed. A fee of 25 is payable on appointment. Qualifications (a) Practitioner of the Supreme Court of three years standing; (b) Practitioner of the Court and has practiced for seven years as a Public Notary in some part of the British Dominions.
