Stealing in Dwellings, from the Person, &c.

During August last, from the hut of Hugh McKenzie, Mallitup River, Kojonup District,—an oppossum skin rug and pair of half-wellington boots. William Jones *alias* James Wilson *alias* Flat Nose Jemmy, suspected.—C.I. 292.

Some time between 4th March and the end of May last, from the sawmill, Jarrahdale,—the friction gear of engine, consisting of six spindles and large slotted iron wheels 1ft. in diameter, six pulleys 1ft. in diameter, 3ft. wide, and connecting rod of iron about 5ft. long; this machinery is perfectly useless to any other mill in the Colony, and is valued at £250; also a quantity of carpenter's tools and iron bars, picks, shovels, and steel bars for boring; the iron tools are marked R. C. and the wooden ones R. J. C. over L. Any information that can be gleaned respecting these things, report to be sent to Detective Office.—C.I. 293.

On 25th ult., from premises of L. A. Manning, Henry Street, Fremantle,—large size square bladed shovel, is much worn, blade broken in two places; the property of John Rankin.—C.I. 294.

On 22nd ult., from the dwelling house of Robert Flint, of the Mackie Bridge,— \pounds 1 bank note, No. and bank not known, fifteen shillings and sixpence in silver, two white sheets, two white blankets, counterpane, and white diaper towel; all property, with the exception of the money, recovered. 1. HENRY RINGTON, Reg. No. 4620, Imperial Convict; arrived in the colony per convict ship Nile, in January, 1858. Description—Middling stout, present age 45, 5ft. 9in. high, sandy hair, dark brown eyes, long visage, fresh complexion. Marks—H.K. on each arm; a farm laborer. Absconded from a Convict Party at Point Resolution on the 10th October, 1868. HENRY RINGTON is shown in list of convict ship "Nile" as Henry Rington; but in another part of ship list he is shown as Henry Kington, with the same description, &c. There is evidently some mistake in spelling the name, and he may be going in the name of Kington.

3. WILLIAM GOODLAND alias BILL ATTEL, Reg. No. 8269, Imperial Convict; arrived in the Colony per convict ship Racehorse, 1865, under sentence of 20 years, p.s., March, 1863. Description—Stout, broad shoulders, present age 34, 5ft. $7\frac{3}{4}$ in. high, dark brown hair, bald, light hazel eyes, long visage, fair complexion. Marks—Anchor and J right arm; sailor and mermaid left arm; a carpenter; has a spot size of half crown on left side of head void of hair; has been in Royal Navy; an Englishman; walks with a quick short step, turns right foot outward. Absconded from Convict Boat Party, Fremantle, on the 16th December, 1870, and is believed he went overland to South Australia with Bernard Stein in October, 1874.

5. JAMES BAKER, Reg. No. 9068, Imperial Convict; arrived in the Colony per convict ship Corona, 1866, under sentence of 15 years p.s., 25th March, 1865. Description—Slight, present age 69, 5ft. $3\frac{1}{2}$ in. high, grey hair, grey eyes, round visage, dark complexion; a laborer. Absconded from Northam Convict Road Party on the 11th July, 1871, last heard of at DeBurgh's, Moore River.

6. HENRY BRADBURY, Reg. No. 5979, Imperial Convict; arrived in the Colony per convict ship Lincelles, January, 1862. Description—Stout, present age 35, 5ft. $5\frac{1}{2}$ in. high, light brown hair, light hazel eyes, long visage, fresh complexion; a butcher. Absconded from Convict Boat Party, Fremantle, on the 3rd April, 1872.

7. DENNIS MANNING, Reg. No. 9513, Imperial Convict; arrived in the Colony per convict ship Norwood, July, 1867; sentenced to 10 years in 1865, but received additional sentences in this Colony for larceny. Description—Stout, present age 39, 5ft. 2in. high, black hair, black eyes, round visage, swarthy complexion; a laborer. Absconded from Freshwater Bay Road Party on the 10th May, 1873. DENNIS MANNING is further described, for information of police, as an Irishman, short necked, has a Jewish appearance, walks with a rolling gait, has a deal to say, especially upon horses, carries his arms wide from his body, and will most likely pass for a groom, and he has a good knowledge of horses.

8. JOHN OF JAMES KEARNS, Reg. No. 10097, Colonial Convict; under sentence of 5 years p.s., at Albany, on the 19th February, 1873, his Imperial Reg. No. was 7747, sentence 6 years p.s., on the 7th May, 1861. Description—Stout, present age 39, 5ft. 4in. high, brown hair, oval visage, dark complexion, Marks—Bayonet stab in neck, D left side, bullet mark on right leg, willow left arm, J. right arm; a laborer. Absconded from Point Resolution Road party on the 10th August, 1873.

9. HENRY PARKENSON, Reg. No. 8674, Imperial Convict; arrived in the Colony per convict ship Vimiera, December, 1865, reconvicted for larcenies in this Colony. Description—Middling stout, present age 36, 5ft. $6\frac{2}{4}$ in. high, brown hair, grey eyes, oval visage, fresh complexion. Marks—Dot and H on left arm; a laborer. Absconded from North Fremantle Depôt on the 8th March, 1874, believed to be in or near Perth.

29. JAMES FOSTER, t.l., Reg. No. 8263. Description—stout, age 33 years, height 5ft. $5\frac{3}{4}$ in., brown hair, hazel eyes, oval visage, sallow complexion. Marks—flags, D, 18, 1863, right arm; anchor, dart, heart, crown, and bracelets, left arm. Absconded while on pass from Fremantle to York, from 5th to 9th inst.

30. CHARLES FERGUSON, exp., late Reg. No. 7989. Description—Thin, 46 years of age, 5ft. $9\frac{1}{2}$ in. high, dark hair, dark hazel eyes, sharp visage, dark complexion; scar right side of cheek; is a shoemaker. Absconded from Geraldton Local Gaol, on 28th ult.; re-convicted at Quarter Sessions, Geraldton, on 7th June, 1876, on charge of forging and altering cheques, and sentenced to 7 years' p.s.

32. BENJAMIN COUNT, t.l., Reg. No. 4642. Description—Slight, 41 years of age, 5ft. $3\frac{3}{4}$ in. high, brown hair, turning grey, grey eyes, oval visage, fresh complexion, has a cut on upper lip, has absconded from the Wellington district while on pass to seek work from 25th September to 1st October, 1876.

33. JAMES A. MCDERMOTT, t.l., Reg. No. 8358. Description—Middling stout, 40 years of age, 5 feet 8 in., auburn hair, blue eyes, long visage, fair complexion, marks on person—shield right instep, anchor on calf of right leg, garter right leg, snake left foot, star on left calf, garter, American coat of arms, brig in full sail, sailor and ensign right arm, bracelet right wrist, anchor and rings three fingers right hand, anchor, Claris Hughes, wreath, and James Davenny and woman left arm; bracelet on left wrist, anchor and heart on second finger, anchor on third finger left hand, woman on breast; absconded from Wheal Ellen mine, Northampton district, on or about 22nd ult. Joseph Lovatt, exp., late 9228, is reported as living with McDermott's wife somewhere on Back Greenough Flats, and it is likely McDermott will make for there.
