## Stealing in Dwellings, from the Person, &c.

Report has been made to P.C. Hackett, at Youingup, that a native named "Old Kenny," of that place, had been murdered by a native named "Billy Yambinguitt," on the 6th ult., at the Muradonging Pools, spearing him. P.C. Hackett arrested the offender, who afterwards dragged him off his horse and escaped; P.C. Hackett shot at him three times, wounding him in the right thigh, but that did not prevent the prisoner escaping. The body of the murdered native was afterwards exhumed, and a spear wound was seen going into the top of the left shoulder, coming out at the bottom of the throat. Warrants will be applied for.

Innibetts Piccaniny discharged same day, on charge of killing 2 bullocks, the property of William Nancarrow, at the Murchison, about 27th July, 1876.

INNIBETTS PICCANINY, and MOONDYTS, ab. natives, sentenced on 27th ult., at Geraldton Police Court, to 18 months' hard labor each. Innibetts Piccaniny's sentence to be cumulative; on charge of killing Andrew Ogilvie's horse, about November, 1876, on the Murchison.

MOONDYTS, ab. nat., brought up on remand, and discharged on case of stealing sheep from Michael X Morrissey, on 11th June, 1876.

MOONDYTS, WORROBANDY, NANGY alias MENDIC BILLY, CEWARY, BUNDI, INNIBETTS PICCANINY, and GINERWANGAH; charged at Geraldton Police Court, with stealing and killing sheep, the property of Thomas Drage, on the Murchison, on 1st ult. Bundi and Ginerwangah sentenced to 2 years', the others sentenced to 18 months' hard labor at Rottnest. Innibetts Piccaninny and Moondyts to be cumulative on first sentences.

#### Absconders.

1. HENRY RINGTON, Reg. No. 4620, Imperial Convict; arrived in the Colony per convict ship Nile, in January, 1858. Description—Middling stout, present age 45, 5ft. 9in high, sandy hair, dark brown eyes, long visage, fresh complexion. Marks—H.K. on each arm; a farm laborer. Absconded from a Convict Party at Point Resolution on the 10th October, 1868. HENRY RINGTON is shown in list of convict ship "Nile" as Henry Rington; but in another part of ship list he is shown as Henry Kington, with the same description, &c. There is evidently some mistake in spelling the name, and he may be going in the name of Kington.

2. JOHN O'REILLY, Reg. No. 9843, Imperial Convict; arrived in the Colony per convict ship Hougoumont, in 1868; sentenced to 20 years, 9th July, 1866. Description—Healthy appearance, present age 30, 5ft. 6in. high, black hair, brown eyes. oval visage, dark complexion; an Irishman. Absconded from Convict Road Party, Bunbury, on the 18th February, 1869. It has been ascertained that the above absconder is at Boston, Massachussetts, U.S.A. He is at present co-proprietor of a newspaper named "The Pilot."

3. WILLAM GOODLAND alias BILL ATTEL, Reg. No. 8269, Imperial Convict; arrived in the Colony per convict ship Racehorse, 1865, under sentence of 20 years' p.s., March, 1863. Description—Stout, broad shoulders, present age 34, 5ft.  $7\frac{3}{4}$  in. high, dark brown hair, bald, light hazel eyes, long visage, fair complexion. Marks—Anchor and J right arm; sailor and mermaid left arm; a carpenter; has a spot size of half crown on left side of head void of hair; has been in Royal Navy; an Englishman; walks with a quick short step, turns right foot outward. Absc nded from Convict Boat Party, Fremantle, on the 16th December, 1870, and is believed he went overland to South Australia with Bernard Stein in October, 1874.

5. JAMES BAKER, Reg. No. 9068, Imperial Convict; arrived in the Colony per convict ship Corona, 1866, under sentence of 15 years' p.s., 25th March, 1865. Description—Slight, present age 69, 5ft.  $3\frac{1}{2}$ in. high, grey hair, grey eyes, round visage, dark complexion; a laborer. Absconded from Northam Convict Road Party, on the 11th July, 1871, last heard of at DeBurgh's, Moore River.

6. HENRY BRADBURY, Reg. No. 5979, Imperial Convict; arrived in the Colony per convict ship Lincelles, January, 1862. Description—Stout, present age 35, 5ft.  $5\frac{1}{2}$ in. high, light brown hair, light hazel eyes, long visage, fresh complexion; a butcher. Absconded from Convict Boat Party, Fremantle, on the 3rd April, 1872.

8. JOHN OF JAMES KEARNS, Reg. No. 10097, Colonial Convict; under sentence of 5 years p.s., at Albany, on the 19th February, 1873, his Imperial Reg.
