# Stealing in Dwellings, from the Person, &c.

On the 2nd February, 1877, from the hut of Francis Wheeler, Preston River,—one small round looking glass, one butcher's knife, about 9in. long, with dark wooden handle and brass rivets, and one small comb with "Francis Wheeler," scratched upon it. Billy Borage, ab. native, committed the robbery. A warrant has been issued for his arrest.—C.I. 108.

On the 27th ult., from the schooner "Planet," while laying off the Vasse Jetty, the property of Henry Sutcliffe,—one Enfield rifle, No. not known, the top of the barrel has been filed.—C.I. 109.

On the 25th ult., from a hut at the 12-mile Spring, Toodyay Road, the property of Michael Murkey, one pair of laceup boots, nearly new, size 7, large copper sprigs in the soles, tips on heels, two holes cut in top of tongues to put laces through, one small looking glass, one purse, and 4 sticks of tobacco. A man about 5ft. 6in. high, slightly pockpitted, dark hair, wore a dark billycock hat, mole trousers, light tweed vest, and light boots with large nails round the heels, suspected of this robbery, and was seen at the Tea Tree Swamp going towards Toodyay, on 26th ult.—C.I. 110.

On the 3rd February, 1877, from the hut of William A. Spencer, of Quindinmillup,—one looking glass,  $7 \times 5$ , marked on top, bottom, and sides, with W.A.S., also 3 notches cut on each square, one pocket knife, two blades, two notches cut on each and of handle, one tomahawk (American) marked W filed on the head, also a small quantity of rice, tea, and sugar. Niarmit alias Jacob, ab. native, committed this robbery.—C.I. 111.

Sometime during December, 1876, from the premises of Randell, Knight, and Co., their property,—a quantity of union joints, marked L.B. in a triangle, O.—C.I. 112. On the 29th ult., from the person of Edwin Knott, of York, while in the Shamrock Hotel, Perth,—a pocket book containing four one-pound notes, numbers or bank not known.—C.I. 113.

1. HENRY RINGTON, Reg. No. 4620, Imperial Convict; arrived in the Colony per convict ship Nile, in January, 1858. Description—Middling stout, present age 45, 5ft. 9in high, sandy hair, dark brown eyes, long visage, fresh complexion. Marks—H.K. on each arm; a farm laborer. Absconded from a Convict Party at Point Resolution on the 10th October, 1868. HENRY RINGTON is shown in list of convict ship "Nile" as Henry Rington; but in another part of ship list he is shown as Henry Kington, with the same description, &c. There is Pevidently some mistake in spelling the name, and he may be going in the name of Kington.

2. JOHN O'REILLY, Reg. No. 9843, Imperial Convict; arrived in the Colony per convict ship Hougoumont, in 1868; sentenced to 20 years, 9th July, 1866. Description—Healthy appearance, present age 30, 5ft. 6in. high, black hair, brown eyes. oval visage, dark complexion; an Irishman. Absconded from Convict Road Party, Bunbury, on the 18th February, 1869. It has been ascertained that the above absconder is at Boston, Massachussetts, U.S.A. He is at present co-proprietor of a newspaper named "The Pilot."

3. WILLAM GOODLAND alias BILL ATTEL, Reg. No. 8269, Imperial Convict; arrived in the Colony per convict ship Racehorse, 1865, under sentence of 20 years' p.s., March, 1863. Description—Stout, broad shoulders, present age 34, 5ft.  $7\frac{3}{4}$ in. high, dark brown hair, bald, light hazel eyes, long visage, fair complexion. Marks—Anchor and J right arm; sailor and mermaid left arm; a carpenter; has a spot size of half crown on left side of head void of hair; has been in Royal Navy; an Englishman; walks with a quick short step, turns right foot outward. Absconded from Convict Boat Party, Fremantle, on the 16th December, 1870, and is believed he went overland to South Australia with Bernard Stein in October, 1874.

5. JAMES BAKER, Reg. No. 9068, Imperial Convict; arrived in the Colony per convict ship Corona, 1866, under sentence of 15 years' p.s., 25th March, 1865. Description—Slight, present age 69, 5ft.  $3\frac{1}{2}$ in. high, grey hair, grey eyes, round visage, dark complexion; a laborer. Absconded from Northam Convict Road Party, on the 11th July, 1871, last heard of at DeBurgh's, Moore River.

JAMES BAKER, Reg. No. 9068, imp. convict, is reported as being employed at Whitfield's place, on Pontt's Station, Upper Irwin, as cook. Immediate enquiry to be made and report sent to Detective Office.

6. HENRY BRADBURY, Reg. No. 5979, Imperial Convict; arrived in the Colony per convict ship Lincelles, January, 1862. Description—Stout, present age 35, 5ft.  $5\frac{1}{2}$ in. high, light brown hair, light hazel eyes, long visage, fresh complexion; a butcher. Absconded from Convict Boat Party, Fremantle, on the 3rd April, 1872.

8. JOHN OF JAMES KEARNS, Reg. No. 10097, Colonial Convict; under sentence of 5 years p.s., at Albany, on the 19th February, 1873, his Imperial Reg. No. was 7747, sentence 6 years p.s., on the 7th May, 1861. Description—Stout, present age 39, 5ft. 4in. high, brown hair, oval visage, dark complexion. Marks—Bayonet stab in neck, D left side, bullet mark on right leg, willow left arm, J. right arm; a laborer. Absconded from Point Resolution Road Party on the 10th August, 1873.

9. HENRY PARKENSON, Reg. No. 8674, Imperial Convict; arrived in the Colony per convict ship Vimiera, December, 1865, reconvicted for larcenies in this Colony. Description—Middling stout, present age 36, 5ft.  $6\frac{2}{4}$ in. high, brown hair, grey eyes, oval visage, fresh complexion. Marks—Dot and H on left arm; a laborer. Absconded from North Fremantle Depôt on the 8th March, 1874, believed to be in or near Perth.

29. JAMES FOSTER, t.l., Reg. No. 8263. Description—Stout, age 33 years, height 5ft.  $5\frac{3}{4}$ in., brown hair, hazel eyes, oval visage, sallow complexion. Marks—Flags, D, 18, 1863, right arm; anchor, dart, heart, crown, and bracelets, left arm. Absconded while on pass from Fremantle to York, from 5th to 9th September, 1876.

40. JOHN PACEY, t.l., Reg. No. 9543. Description—middling stout, 32 years of age, 5ft.  $4\frac{1}{2}$ in., brown hair, grey eyes, round visage, fair complexion; is a baker; has absconded from Perth District, on the 20th January, 1877. This absconder is also charged with stealing fruit from Mr. G. Shenton's garden, Perth, on 20th inst. Pacey is strongly suspected of having passed through Fremantle, on night of 22nd January, *en route* for Bunbury *via* Rockingham.
