Stealing in Dwellings, from the Person, &c.

The dog therein described has been recovered on board the "Macquarie" at Fremantle.

shrouds, two cargo gins, one patent claw and chain, four side lamps, three cork fenders, one set chain boat lashings, three crow bars, one grind stone, sundry carpenter's tools, one deep sea lead, six luff tackle blocks, two stoppers, eight shank painters, galley, stove, and cooking utensils, dunnage wood and nails, two spare spars and one boat.
