### Stealing in Dwellings, from the Person, &c.

On the 30th ult., from Hartly Bowen's residence, Murray Street, Perth,-new horse rug, two holes burnt in edge, yellow color, with dark brown stripes. Mary King alias Black Poll, Thomas Lynch, exp., 8638, and Charles Darby, exp., 7092, suspected.— C.I. 249.

Sometime since November, 1876, from H. Yelverton's saw mill station, Quindalup,-pair of small cart arms and boxes, about 2in. diameter. James Rodgers, exp., late 1422, suspected.-C.I. 250.

On the 2nd inst., from John Weedon's dwelling house, West side of Canning River,-light tweed coat, two side pockets and one breast pocket moth eaten, quart pannican, small piece broke out of handle, one yard of calico, about 4lbs. beef, small pasteboard box, containing pepper and salt and 20 eggs, the property of John Weedon.—C.I. 251.

On 2nd inst., from Mr. Fouchard's premises, Wellington Street, Perth,—pair lady's drawers. Description—white, trimmed with embroidery.—C.I. 252.

On 25th ult., from J. S. Roe's residence, Adelaide Terrace, Perth,-American axe, 7ths. weight, with new handle, chip out of the axe.-C.I. 253.

On 14th ult., from John Marshall's hut, Corinien, Bannister District,-one tomahawk, quart pannican, 40lbs. flour, 5lbs. sugar, 3lb. tea, 5lbs. salt pork, 7 sticks tobacco, and 3 boxes matches. Also, from John Jackson's hut, same place and date, 10ths. flour, 21bs. sugar, 12b. tea, and one butcher's knife.-C.I. 254.

On 20th June, from Mark Edwards' hut, Dangalocking, Williams River, common horse rug, with dark stripes, lined with linsey, Crimean shirt, dark stripes, pair moleskin trowsers, 40ths. flour, and 14 stripes, pair indexan constant groups, exp., late 9212, suspected; this man is at present undergoing a sentence of 6 months'. Vide Police Gazette, 1877, page 106.-C.I. 255.

On the 5th ult., from John Chapman's hut, Tambeling Lake, Williams River,-Crimean shirt, light color with dark stripes, one cotton shirt, striped pattern, one American axe, one tomahawk, and 100ths. flour. This robbery was committed by ab. natives East of the Williams, as the shirts were seen on them a few days after.-C.I. 256.

Between 8 a.m. and noon of the 29th ult., from the dwelling house of the Rev. R. Martelli, New-castle,—small round tin box, containing two or three pounds in silver, one order drawn on G. Shenton, by Bishop Salvado, favour of R. Martelli, No. 5288, Jord supposed date 19th July, amount £2, silver pix, and shape of round box, about 2in. in diameter, lid comes off, gilt inside, this was wrapped in a brown skin purse, three small round silver vessels, about one inch high, about one inch in diameter, lids come off and gilt inside, these vessels were in a black ebony case; also between 30 and 40 metal medals, some have the appearance of silver, different sizes, some bears the inscription, first communion, some the sacred heart, also some small rings for children. This robbery was effected by the front door being left unlocked, while the Rev. R. Martelli was absent at the Wicklow Hills, a track of a small size, plain, smooth soled boot was seen about the house.-C.I. 257.

Sometime since 20th December, 1876, from the Jarrahdale Timber Co.'s Works, Jarrahdale,—a number of American axes, branded J.T.C. on handle, and J.C. on the iron, a number of shovels, branded on the wood J.T.C., and J.C. on the iron, a number of hammers, various sizes, varying from  $\frac{1}{2}$ th to 5ths. in weight, branded as above. Also several chains, 9 feet long, not branded. Identifiable. James McDonald, t.l., Reg. No. 5651, and Thomas Stevens, exp., strongly suspected.-C.I. 258.

Between the 21st and 22nd July, from Thomas Churchill's hut, Kojonup,-Crimean shirt, shepherd's plaid, 6fbs. sugar, 1/2 fb. tea, 3fbs. currants, 1/2 fb. thread, pair mole trowsers, pair cotton drawers, dungaree shirt, flannel shirt, 3 yards black braid, one grey felt hat, oppossum skin rug lined with blanket, thimble, saucepan, half a sheep, piece of rope, 2 pannicans,

one tomahawk, butcher's knife, blue dungaree cap, one leather bag, shot belt, about 3 lbs. shot,  $\frac{1}{2}$  lb. powder, one powder flask,  $1\frac{1}{2}$  boxes Holloway's pills, 1 lb. alum, 1 pair woollen socks, 1 box gun caps, 1 bar soap, 17fbs. flour in a bag, 2fbs. sugar,  $\frac{1}{4}$ fb. tea, one double barrel gun, one sheep, one glass syringe, one comb, and one shoemaker's awl. Tribe of Eastward natives suspected.-C.I. 259.

On 27th June, from James Quinn's dwelling house, Kojonup,-man's riding saddle, much worn, knife cut on seat near crupper, off side near pad nearly new, sewn at top, two old stirrups attached, one with bar in centre ; also one single bridle. These articles were obtained by a man named McIntosh, last heard of at Eyer's Sand Patch.-C.I. 260.

On 25th ult., from John Campbell's hut, Quin-dalup,—pair of white moleskin trowsers, size 5, Crimean shirt new, grey color with black stripes. Not identifiable.—C.I. 261.

On 10th August, 1876, from the person of Thomas Clark, while drunk near Geraldton,—an open faced <sup>3</sup>/<sub>4</sub> plate Geneva silver watch, number believed to be about 11010, or very near that number. John Fisher, exp., and Robert Dougherty, exp., strongly suspected.—C.I. 262.
