William Waldergrave, Rear-Admiral Parker, and Commodore Nelson for their gallant behaviour on the 14th of February last in defeating the Spanish Fleet, and that they be presented severally with the Freedom of this City in a Gold Box.

NOTE .- Sir Robert Calder omitted by mistake, afterward rectified by a like note.3

Gold sword-hill, presented to Sir Horatio Nelson by the captains of the Fleet present at the Battle of the Nile, 1798, inscribed :-
