Circular Orders and Miscellaneous Information.

The Criminal Code Act, 1902.

In connection with the Criminal Code Act, which came into force on the 1st inst., Officers in charge of Districts are requested to make the very closest study of the provisions of the Code, in order that they may be in a position to properly instruct and direct members of the force in their respective commands in the administration of this important measure.

The Code alters, repeals, or varies the existing law and statutes to such an extent that unless the utmost care and judgment is exercised in the enforcement of its provisions, it is clear that very grave difficulties and complications may result.

Officers will therefore use every diligence in mastering the details of the Act themselves, and will insist on the subordinate members of the force under their direction devoting as much time and attention as is practicable in acquiring a knowledge of the Act.

A copy of the Code has been already posted to each district officer, and a sufficient number of copies will be despatched to the different districts to supply each member of the force as soon as it is possible to obtain them from the Printer.


