Circular Memorandum.

ASSAULTS ON POLICE.

(Section 316, Criminal Code.)

The following copy of an opinion of the Crown Solicitor bearing upon two recent cases in which the offenders were committed for trial under Section 316, Criminal Code, for assaulting police officers, is published for the information of members of the force :—

Commissioner of Police,

1-9-1902.

I do not think that it was ever intended to require every assault upon a policeman to be inquired into before a jury. Rather would I suggest the other course, that assaults on constables should be treated as common assaults, determined summarily, unless the Justices hearing the case should think it sufficiently grave or serious to warrant it being dealt with by a higher tribunal.

The R.M., as grand juror, would probably throw out the bill-I should—and let the prosecutor go before a J.P., under Section 319.


