### Circular Orders and Miscellaneous Information.

REVENUE AND REFUND RETURN.

C.O. 25/1903.—A new form of return of revenue, etc., collected and moneys refunded will replace the old "Refund Return form (P26)" from the 1st July, 1903. Supplies of these forms are now being issued to District Officers, who will see that a sufficient number are forwarded to each station.

The return must show from whom moneys are collected, as well as details of the nature of the service, date, time occupied, and for whom performed. The full particulars of moneys refunded must be clearly shown. Moneys connected with the estates of lunatics and intestates passing through the hands of police will also be entered. The return must be furnished promptly at the close of each month.






