Circular Order and Miscellaneous Information.

C.O. 1870.—In connection with the recent inquiry into the case of John Behan, who was summarily convicted at Perth Police Court of escaping from lawful custody on the 26th February last, and who was also tried and convicted at the Supreme Court in March, in conjunction with John Francis Bourke and Patrick Murphy on a charge of breaking and entering, the following clause from the report of His Honour the Acting Chief Justice, who conducted the inquiry, is published for the information and guidance of the Police in future cases:—

"13. On the 26th February Behan was summarily convicted at the Perth Police Court of escaping from lawful custody, and sentenced to 3 months' imprisonment with hard labour. In convicting him of this offence the Justices must have found that he was the man who was in Murphy and Bourke's company on the morning of the 14th February. As this was the question the jury had to determine on Behan's trial in the Supreme Court, and the fact of his conviction in the Police Court probably became public through the Press, such conviction was obviously calculated to prejudice the jury against him, and may have had that affect. I think this charge should not have been made until the Jury had decided the question at issue. Had the Jury acquitted Behan he would nevertheless be still convicted of, and still serving a sentence for, escaping from a custody in which the Supreme Court declared he never was. In such circumstances the remainder of the sentence would undoubtely be remitted, discredit would be thrown on the administration of justice in the Police Court, and Behan would have good reason to consider himself a very illused and persecuted individual."
