#### SUPPOSED ARSON-£100 REWARD.

WHEREAS on the night of the 30th of November, 1897, the premises known as M. J. Solomon & Co., situate at Wellington Street, West Perth, owned by Henry Goodhill, and occupied by M. J. Solomon & Co., were destroyed by fire. In addition to the above reward, His Excellency the Governor will be advised to extend a free pardon to any accomplice, not being the person who actually set fire to the said property, who shall first give such required information.
