

JOLIMONT, St Hughs Church. ANGLICAN CHURCH

In 1919, St Hugh's joined with St Edmund's of Wembley to become a joint parochial district under Rev A. Kirby and later Rev Wilf Painter. St Hugh's returned to the parish of Subiaco in 1941 and St Edmund's became a separate parish. St Hugh's church closed in the early 1980s and was transferred to the Coptic Church. St Hughes, Jolimont worked closely with St Andrews, Subiaco and some records of St Hughes are found in volumes from St Andrews Church.
