3843A/4 Church registers	26 January 1945 – 29 January 1958 Burials. This register is only half full and relates to burials in the Parish of Merredin during 26 January 1945 to 29 January 1958
	<i>Service</i>
3843A/15	1934-1981 7 October 1934 to 12 November 1939. Service. Includes services, details of activities at All Saints Church Merredin and surrounding centres, including names of preachers, baptisms, confirmations, social functions etc. Also includes loose sheet entitled "Aborigines of the Inland", evidently script for audio-visual
3843A/16	3 December 1939 – 3 September 1943 Services. Includes services and details of activities at All Saints Church Merredin and its surrounding district
