

GRAND LODGE OF WESTERN AUSTRALIAN FREEMASONS (INC) AVALON LODGE No. 295 WAC

The Lodge was consecrated on 31 March 1953 by the Grand Master M.W. Bro J.A. Ellis CBE, at the Masonic Hall, Herbert Rod, Shenton Park. The Lodge amalgamated with Wandana Lodge no. 323 WAC on 30 April 1990, under the name of Wandana Avalon Lodge, no. 295 WAC. However, on 7 May 1992, the Lodge received permission from the Board of General Purposes to delete Wandana from its title and revert to the original name of Avalon Lodge no. 295 WAC
