

GRAND LODGE OF WESTERN AUSTRALIAN FREEMASONS (INC)

The Grand Lodge of Western Australia was regularly formed on 27 February 1900, when His Excellency, Sir Gerard Smith K.C.M.G. was installed as the first Grand Master in the Government House Ballroom. The Installing Officer was R.W. Bro. Bishop (later Archbishop) C.O.L. Riley P.G.C. (E.C.), who subsequently became Grand Master of this Constitution.
