

## GRAND LODGE OF WESTERN AUSTRALIAN FREEMASONS (INC) SERPENTINE LODGE NO. 301 WAC

The lodge was in existence from 20 October 1953 (Consecration) meeting at the Masonic Hall, Mundijong until 20 October 1960. From this date the lodge met at the Armadale Masonic Hall Complex, Cnr Fourth Road and Church Ave, Armadale to better accommodate its members.

The lodge continued to meet until 2001 when it entered into a co-operative arrangement with The Goolamrup Lodge no. 94 WAC where each lodge maintained its own individual Master, Secretary, Treasurer and Charity Steward but shared all other offices. The members of both lodges becoming Associate members of the other, meeting each month alternately under the supervision of each of the respective Masters.

On the 22nd April 2004, The Goolamrup Lodge brethren voted to officially change the lodge name to 'The Armadale Lodge No. 94', to better reflect the location of the Lodge within the community and with a view to bring the very successful 'twinning' arrangement with Serpentine Lodge to finalisation.

On the 26th June 2004, after 51 years existence, Serpentine Lodge No. 301 surrendered its Warrant, its brethren transferring their allegiance, becoming full members of The Armadale Lodge No.94.
