

GILL, Andrew William (1949 -)

Born in Derby, England, Andrew Gill arrived in WA in 1969, and graduated from the University of WA in 1973. Between 1972 and 1981, he pursued private research into various police forces in Australia, including the WA Police. From 1981, he worked as a contract research assistant on a variety of projects all connected with the history of WA.

The following brief guide was compiled by Andrew Gill. The accession 4046A/1-112 represents roughly three areas or periods of research:

- 1. My own personal research on Australian Police Forces, generally from the period 1972-1981 (4046A/1-49)
- 2. Papers remaining from various projects on which I worked as a research assistant, from 1981 to the present (4046A/50-59)
- 3. Papers relating to the Philanthropic Society (4046A/60-69), the Children's Friend Society (4046A/70-97) and Parkhurst Prison, and the convicts sent to Western Australia during the 1840s (4046A/98-112).

1 My personal research began in 1972-1973 with an abortive attempt to write a B.A. Honours Thesis on the WA Police. The main bi-product of this research was 'Aspects of the Western Australian Police Force 1887-1905'. The copy of this typescript which appears on the shelves of the Battye Library (Q363.2) has 4 chapters, and was retyped for me by the WA Police Department (except for the tables in chapter 2 which are photocopies of my original typing). The original typescript (4046A/5) had two other chapters which were not submitted to the attention of the WA Police, one on Corruption (4046A/6) and the other on Police and Aborigines in the Kimberleys (4046A/7). The chapter on Aborigines was revised (4046A/8) and later published as 'Aborigines, settlers and police in the Kimberleys 1887-1905, Studies in Western Australian History vol. 1, June 1977 pp. 1-29. All these items were researched and written between 1972 and 1974.

A large part of 'Aspects', particularly chapter 3, had been concerned with an attempt to find out 'who joined the WA Police?'. The figures in this chapter were derived from volumes of applications to join the WA Police (WAS 333 cons 949/1). This information was sorted on cards (4046A/22). I continued my research on this matter, writing to archives, individuals and libraries seeking information on individual police or possible references to enable me to make comparisons with other police forces (4046A/1-2, 4, 9).

In late 1976, I moved to Adelaide in search of work and continued my research on 'Who joined the Police?', now focusing more narrowly on the social background of the officers (Sub-Inspector and above) in the police forces of eastern Australia. The result of these efforts during 1976-1979 are the biographical sheets and miscellaneous notes on eastern Australian Police Forces (4046A/11-21). The individual sheets are summaries of the information I collected. Further information plus references and sources for the summaries are to be found on the cards for the respective colonies (4046A/23-35).

My original notes on these police forces were made in pencil on the back of scrap paper collected from various rubbish bins. These notes were then re-typed, again on scrap paper, and finally typed again on to cards.

By mutual agreement with the WA Archives, the pencil notes were judged illegible and junked, leaving only a modest amount of typescript notes and the cards, plus occasional photocopies. No publication resulted from my research on the eastern Australian Police, because the information collected was exceedingly elementary and patchy in content. While I was in Adelaide, I 'wrote up' some of my notes on the WA Police and on 'crime' in WA, 1868-1914. These notes (4046A/42) were all written and collected before 1979. They reflect the limited interest in academic circles about issues of crime and police. They also reflect the period before the upsurge in interest in WA history at the time of the 'sesquicentenary' of WA in 1979.

In mid 1979, I returned to WA with the intention of resuming my research on the WA Police. Initially, access to Police records was open, and one of my first acts was to start making an index to the titles of WA Police Department files in Accession 430. The result was 'A Title Listing of Police Department files, 1909-1920'. The unedited version of this listing (4046A/47 & 48) includes occasional comments on the contents of the files which I found particularly interesting. The edited version, without these comments, became part of the 'official' archival listing for accession 430 - still recognisable by its distinctive typing! In early 1980, access to all Police Department records in the WA Archives was closed (see 4046A/3) and I turned to other sources on the Police force. The result was 4046A/49: 'A Select List of Colonial Secretary's office files relating to the Criminal Injustice System of Western Australia 1888-1899, Perth 1980. A copy of this List is available in the Battye Library (Q016.36499). At this time, 1979-1981, I continued my research on the officers in the WA Police. The result is the biographical sheets (4046A/11 & 12). These sheets are the summaries of information collected prior to the publication of the various Dictionaries of Western Australians that appeared in the 1980s. The full information on each individual and the sources used remain on cards, which I retain in my possession (March 1996).

In September 1981, I gave a seminar paper at the University of WA which summarised part of my research on 'Who joined the WA Police' and on the social background of the 'officers' in the WA Police (1870-1914). This paper included some figures from Victoria in 1888 derived from information supplied through the Victorian Parliament (4046A/1). The seminar paper is available in the Battye Library as a monograph (Q363.2*GIL).

Since 1972, I have kept an ongoing bibliography of books, journal articles and possible primary sources for a history of crime, police, prisons, courts, etc. Volumes of this bibliography are now 4046A/43-46.

2 Research projects in the 1980s

Between 1980 and 1983, I worked with Dr C T Stannage on a project entitled 'Crime & Society in WA 1830-1914'. This project was funded by the ARGC and later the CRC. A copy of the report on this project is available in the Battye Library (Q364.99*GIL). A first consignment of the papers, notes and indexes generated during that project has been donated to the WA State Archives (Accession 4382A - see MN1469 for further details).

From 1982 onwards, this project was part-time one, and I began to take on contract work as a research assistant for various academic institutions, and government departments. These included:

Most of my notes for these projects were taken in pencil on the back of scrap paper. They were then typed up for the current employer. Rarely did I keep a typed copy of my notes. Two exceptions to this rule were: the Goldfields Water Supply Bibliography, and the WA History of the Parliament Project.

My work for the PWD involved making a list/bibliography of all the sources then (1982) in the Battye Library and/or other institutions in WA on the construction of the Mundaring Weir and the pipeline to Kalgoorlie, plus its maintenance and administration to 1947. The resulting bibliography ran to over 100 pages and is held at the Library of the WA Water Authority in Leederville. One of my other tasks involved travelling up the pipeline to the various pumping stations and district offices in search of material which had yet to be sent to the archives. The result of this 'search' was a short report: "Historical records of the Goldfields Water Supply Scheme. A report on a search for archival material' (4046A/51).

The Western Australian Parliamentary History Project requires some slight explanation. My first task as a research assistant to this project was to make a list of all the records of possible interest to the project currently (1984) held in various locations in Parliament House, Perth. The result was a long report, a copy of which is kept in the WA Parliamentary Library. 4046A/53 is a short summary of this longer report. Some fragments of my notes made for this longer report are in 4046A/54. The remainder of my time with this project was spent working for the individual authors who would each contribute a chapter to the volume edited by Dr David Black (see correspondence in 4046A/50). The main authors for whom I worked were: Dr David Black, Peter Boyce, Michael Wood, Lenore Layman and Dr. Geoff Gallop (whose chapter was not published due to his election the WA Parliament). The surviving typed notes from this project are 4046A/55-59.

3a The Philanthropic Society

Up to 1982, my personal research concentrated on the topics of Police and Crime in Western Australia up to 1914. From 1983, my focus was on three institutions which sent immigrants, and convicts, to Western Australia between 1834 and 1855. The first of these was the Philanthropic Society which despatched 45 'juvenile immigrants' to Western Australia between 1848 and 1854 (see 4046A/61). Items 4046A/60-69 are mainly notes about the Philanthropic Society as it existed in England, first at Southwark in London and then at Red Hill in Surrey. 4046A/62-67 are notes from documents held in the Surrey Records Office, Kingston-on-Thames. No publication has resulted from this research.

3b <u>The Society for the Suppression of Juvenile Vagrancy, later known as The Children's Friend</u> Society

Items 4046A/70-69 are notes from sources in England on the SSJV and the CFS. 4046A/50 is the draft of a chapter for possible inclusion (not published) in the volume of essays edited by Pen Hetherington - Childhood & Society in Western Australia (Perth, 1988). 4046A/95 is a much longer and more complex draft, with chapters on both the CFS in England and in Western Australia.

In 1993, Geoff Blackburn published The Children's Friend Society. Juvenile Emigrants to Western Australia, South Africa and Canada 1834 - 1842 (Perth, Access Press, 1993) - Battye Library 305.906* BLA. This monograph employs all of the sources which I consulted for 4046A/70-79, and many more of which I was unaware.

3c Parkhurst Prison and its Convicts

Between 1842 and 1849, 234 male juvenile convicts, aged 10 to 20 were despatched from Parkhurst Prison in the Isle of Wight to the 'free' colony of Western Australia. Despite repeated references to them in contemporary sources as 'lads', 'boys', 'youths' or 'juvenile immigrants', they may be legitimately regarded as convicts: they had all been convicted in British courts and sentenced to 'Transportation beyond the seas'. They were just as much CONVICTS as any of the thousands of men, women and children sent to New South Wales or to Van Dieman's Land. CONVICT LABOUR BEGAN IN 1842, NOT 1850!

4046A/98-112 represents the first batch of files containing my research notes on Parkhurst Prison and the convicts who were sent to be 'apprenticed' in Western Australia. All these items are primarily concerned with notes taken from English sources about either Parkhurst Prison, its origins, its staff and its administration (4046A/105-112) or its policy of attempting to discharge its convicts in colonies (4046A/98-101). Only one item (4046A/104) contains notes directly relating to the lives of the 'apprentices' in Western Australia.

So far, (March 1996) the following publications have resulted from my research on Parkhurst and its convicts:

3 and 4. have been combined as a monograph available in the Battye Library (ref Q364.99*GIL).
