

HAMERSLEY FAMILY

Edward Hamersley was born 25 March 1810 [England], arrived 28 February 1837 per Shepherd, married in England Anne Louise [Elvira] Cornelis seven children. Settled at Pyrton and Lockridge in Swan District. Bought grants and established horse breeding stations, at 'Culham' Toodyay, Wilberforce and Woodside at York, and Richmond at Williams. Left for Europe 1843 and returned in 1850. Took up large leases in Irwin and Greenough districts in partnership. Director of the First W.A. Bank in 1841. Held many town allotments in Perth and Fremantle. He was on the Committee of the W.A. Turf Club. Employed ticket of leave men at Greenough and Swan. MLC for Swan 1857 – 1865. Member of the Guildford Board of Education 1861 –1867. Died 26 November 1874

The documents comprising ACC 971A have been arranged for copying mainly in a general sequence in chronological order (regardless of writer) for the years 1845-1892. There are in addition some small groups of letters exchanged between Edward Hamersley and Jane Dempster, whom he married on 4 February 1867, some of which are not dated; and a group of family letters which are undated, and of which in some instances the writers are unidentified.
