

## NGALA MOTHERCRAFT HOME AND TRAINING CENTRE Previously known as The House of Mercy and Alexandra Home for Women

On 23 September 1890 a general meeting of women was held in the Temperance Hall Barrack St Perth to take steps to establish a home for unmarried mothers. The House of Mercy was the name chosen for the institution at a meeting in October of that year. A house in Lake Street was purchased by means of a mortgage of 300 pounds and a 75 pound deposit paid by the committee. By 1894 the Lake Street house proved too small and a building in Aberdeen was rented. In 1900 the Government made a grant of 500 pounds towards the building of a home in Lincoln Street, which was completed and occupied in 1901. In 1916 the name was changed to Alexandra Home for Women and later shortened to Alexandra Home. In 1949 the activities were increased to cover the training of Mothercraft Nurses.

1958 saw the building of a new home in south Perth. The name was changed to NGAL-A, an aboriginal word meaning "We two" of Mother and Child". NGAL-A was officially opened in 1959. The field was widened once again to incorporate the training of essential Infant Health nurses.
