

MULCAHY, Daniel. 1866-1925

Milly Milly Station was purchased by the Mulcahy Brothers, Daniel and Michael, in 1906 when it consisted of 772,000 acres, subsequently increased to 1,500,000 acres by purchase and taking up of adjoining country. In 1911 Daniel Mulcahy became the sole owner. The property was retained by the family until it was sold in 1982. Further information on the history of the property up to the year 1912 has been published in "Cyclopedia of Western Australia" Vol.2.

Daniel Mulcahy was born in Ireland and came to W.A. after the gold rush. The family searched for minerals on their property but were unsuccessful. Daniel owned Central Hotel in Wellington Street, working successfully as a hotel keeper and pastoralist. He was married and had ten children, and died in 1925. His brother Michael also worked in the business.
