

HOPE, P.G.S. & PARTNERS (formerly Hope & Klem)

Carl Hopish Klem arrived in W.A. in 1902 and was employed at Boan Bros, Bellingham & Co. and finally the Titles Office. He resigned from the Titles Office to establish the surveying firm of Hope & Klem, with Percy George Samuel Hope, in 1911.

Klem became involved in the development of many housing estates in the metropolitan and also country areas. The partnership of Hope & Klem dissolved in 1933 because of the Depression. The business carried on under the control of Mr. Hope, eventually becoming Hope P.G.S. & Partners.
