

**BUNNINGS LIMITED**

Arthur and Robert Bunning migrated from London to Perth in 1886 and in 1887 they purchased their first sawmill in the south west of Western Australia, marking the formation of Bunning Brothers Limited. They purchased several more sawmills throughout Western Australia and in 1952 Bunnings Limited became a public company, expanding into the retail market by establishing and buying hardware stores, including the Millars' and Alco Handyman chains. Bunnings was bought out by Wesfarmers in 1994, although the Bunnings retail outlets retained their name. This collection also contains papers from Bunnings' subsidiary companies Carlisle Hardware, Causeway Timber & Salvage Company, A. Douglas Jones & Co., J.R. Parker Pty. Ltd and Perth Jarrah Mills Pty Ltd.
