

ROWELL FAMILY

R.M. Rowell and Company was one of the biggest companies in the Kimberley, encompassing pastoral interests, heavy transport, earthmoving, storekeeping, outdoor cinema and running a pearl lugger.

Founder and family patriarch, Robert Rowell (1914 – 2007) was educated in Perth and, after qualifying as an accountant through part-time study, moved to Derby in 1938 to work for a company which he bought four years later.

Robert Rowell sat as a Justice of the Peace for 66 years, was a major Liberal Party figure, managing the state election campaign which saw Sir Charles Court defeat John Tonkin in 1974, and was Chairman of the Western Australian Coastal Shipping Commission. He was affectionately dubbed "Boab Bob" and was awarded Life Membership of the Pastoralists and Graziers Association of W.A.

He was on the West Kimberley Road Board 1949-1960 and the West Kimberley Shire 1962-1972. Life member of the Liberal Party, he was made a freeman of the municipality of the Shire of West Kimberley in 1977. He was awarded the OBE in 1968 for services to the community and local government. He was married to Ruth Rowell from 1939-1976 and to Angela Devereaux 1977-2007. His business interests also included garages and hotels.
