

PERTH, TRINITY CHURCH. CONGREGATIONAL CHURCH

The first meeting of the group which later became Trinity Church was in October 1843. The first Independent Chapel was completed in 1846. [The name Trinity appears to have been adopted in 1864]. In June 1977 the Church became a Parish of the Uniting Church in Australia.

The Trinity Congregational Church is located in St Georges Terrace, Perth (at 2005).

Restrictions

To comply with adoption and other legislation, the State Library of WA is required to restrict access to

- Baptismal registers with entries dated less than one hundred (100) years
- Marriage registers with entries dated less than seventy five (75) years

To access such registers, researchers must complete an 'Application to View Restricted Records' form, attached at the end of this document, or contact the State Library of Western Australia.
