

AMERICA'S CUP CHALLENGES 1977-1991

This collection tells the story of the Alan Bond inspired challenges for the America's Cup from 1977 to 1991 including the historic win by *Australia II* in 1983 and the staging of the Cup in Fremantle in 1987. As the winning of the America's Cup in 1983 was world-wide news, this was a highly significant achievement for a WA based syndicate. The staging of the next challenge in Fremantle generated a great deal of public support and had a lasting effect on Fremantle and the infrastructure of the city. The syndicate's boat, *Australia IV* did not end up being the challenger but it was an unsuccessful event in any case for *Kookaburra III*, the Australian boat which lost to the American *Stars & Stripes 87*.
