

## MANGURI

Manguri was formerly known as Sister Kate's. It provided residential child care and family support for Indigenous children and families. In 2002 after experiencing considerable financial difficulties and problems with management of the services, Manguri's funding was ceased and the cottages closed. It was located at 190 Treasure Road, Queens Park. Includes information about Yorgum Aboriginal Corporation, a service based at the same location.
