

ST LUKE'S SCHOOL, BEELIAR. UNITING CHURCH

St Luke's School opened in 1998 and was in a joint venture arrangement with Beeliar Primary School, which was the first time in WA that Government and a Non Government school shared facilities in providing schooling for primary age students. St Luke's closed in 2003.
