

KINGSWOOD AND ST COLUMBA COLLEGES. UNITING CHURCH

Kingwood College was one of the residential colleges affiliated with the University of Western Australia. Originally established by the Methodist Church, the College had in recent years been run by the Uniting Church. Kingwood amalgamated with St Columba College (another Uniting Church college) in 2000, to form Trinity Residential College. Kingwood experienced nearly forty years of existence prior to its amalgamation.
