

## SOUTH CANNING PARISH. UNITING CHURCH

Uniting Church - South Canning Parish (June 1977 – July 1981)  
Canning Parish (July 1981 – February 1987)

The former South Canning United Parish, representing the Methodist, Presbyterian and Congregational Churches, became South Canning Parish of the Uniting Church in Australia in June 1977. It consisted at that time of congregations at Cannington and at Willetton [also known as South of Canning Church]

In February 1987 the Parish divided, with Cannington Congregation becoming Cannington Parish, and the Congregations of Willetton, and St Mark's Leeming, forming South of Canning Parish.
