

WEMBLEY-FLOREAT PARISH. UNITING CHURCH

When the Uniting Church was formed in 1977, the Wembley-Floreat Parish was made up of the congregations at Wembley, All Saints Presbyterian Church at Floreat, The Floreat Forum Methodist Church, Wembley Downs Methodist Church and West Leederville Methodist Church.

The West Leederville church closed in 1989. Floreat became a separate parish in 1988, Churchlands Parish, (with no fixed geographical boundaries) was established in 1987, taking members of all these congregations, but especially from Floreat.

Wembley Downs became a separate parish in 1990.

Restrictions

To comply with adoption and other legislation, the State Library of WA is required to restrict access to **Baptismal registers with entries dated less than one hundred (100) years.**

To access such registers, researchers must complete an 'Application to View Restricted Records' form, attached at the end of this document, or contact the State Library of Western Australia.
